3. Submit the Registration form and acknowledgement along with all the supporting documents at the time of admission.
4. Submit photocopies of all certificates for record and originals for verification at the time of admission.
5. Submit latest SC/ST/OBC-NCL certificate in the name of the child preferably, if admission is claimed under caste category.
6. Submit Differently Abled Certificates if admission is claimed under the Differently Abled Quota.
7. Submit an original affidavit, if admission is claimed under Single Girl Child quota.
8. Additional documents to be submitted by the Central/State Govt., Central/State PSUs :-
A. ID Card **B.** Latest Month Pay Slip **C.** Photocopy of the 1st page of the Service Book, where details of the employee are written and the page on which family details are written.
9. Student Id generated through KVS-UBI fee collection portal will be communicated to the parent by the Vidyalaya.
10. By Using Student Id and date of birth of the child, the parent can pay fee via this link :
